



TERMS AND CONDITIONS

1. Seat availability

A total of 297 seats are available for naming opportunities in the Reimagined Barbara Sutton Hall, comprising 21 “Platinum Class” seats, 79 “Gold Class” seats, and 197 “Silver Class” seats.

2. Seat purchase

Official commencement of seat sponsorship will occur on Thursday June 4 when seats may be sponsored by visiting the School’s Website. Seat sponsorship will be strictly on a first-come-first served allocation and the school reserves the right to pause and/or close sponsorship of seats at anytime.

3. Platinum Class benefits

Sponsors of “Platinum Class” seats are eligible for reserved seating of their sponsored seat throughout 2027 at school events held in the Barbara Sutton Hall. Subject to 2027 scheduling, this includes but is not limited to:

- ◆ Secondary School House Music and Dance
- ◆ Secondary School House Drama
- ◆ Senior School Musical
- ◆ VCE Theatre Studies production
- ◆ Years 11–12 Presentation Evening
- ◆ Christmas at Camberwell Festival
- ◆ Barbara Sutton Hall Opening (Second Performance)
- ◆ Junior School Choral and Instrument Concert
- ◆ Junior School Musical

For events where there are multiple performances such as the Senior School Production, the reserved seating only applies for one performance. The School reserves the right to re-schedule such events and locations at its discretion.

4. Opening event access

Sponsors across all three tiers (Platinum, Gold, and Silver) who sponsor a seat by June 4 will be provided access to their sponsored seat at the Barbara Sutton Hall Opening (First Performance).

5. Payment terms

Sponsors are required to make their donation in full for all seats and the accompanying dedication plaque at the time of sponsorship.

All prices are inclusive of GST



6. Plaques

All sponsors of seats are eligible to also have a plaque placed on their sponsored seat. The plaque is Satin Stainless Steel with a Gold Granex Finish, measuring 90mm x 50mm.

7. Plaque wording

The dedication plaque engraved wording allows for the family name and family members who attended Camberwell Girls Grammar School to be recognised. The first one will require sponsors to choose one of the following three options: "Dedicated to", "In honour of" or "Supported by".

The next four lines provide a maximum of 20 characters per line including spaces where sponsors can dedicate a message or family names to be engraved on the plaque.

All wording must be in English.

Seats cannot be sponsored in company names.

8. Plaque placement

For all fixed seats, other than the back rows on Levels One and Two, dedication plaques will be affixed to the back of the seat.

For fixed seats in the back rows on Levels One and Two, dedication plaques will be affixed to the armrest.

9. Right of removal

The School reserves the right to remove a seat plaque at any stage in the future if the actions of the individual or family named may bring the School into public disrepute. Any removal would be subject to review and approval by the Camberwell Girls Grammar School Council, and no refunds will be offered.

10. Availability of unnamed seats

All unnamed seats will remain available for recognition of future sponsors until all seats are sold.

11. Duration

Dedication plaques on fixed seats will remain in place for the life of the building and/or seats whichever is shorter, in accordance with the School's Naming Opportunity Policy.

12. Damage or replacement

If any plaques and/or seats are damaged, a replacement plaque and/or seat will be arranged, with the same terms and conditions applying.



13. Tax status

In accordance with the Australian Taxation Office (ATO) regulations, a tax-deductible receipt cannot be issued for seat sponsorship as the sponsor receives a material benefit in the form of reserved seating (for platinum class seats) and a plaque in return for the payment.

14. Privacy

All information collected for the purpose of this seat sponsorship campaign will be used and stored in accordance with the School's Privacy Policy. Full details of the Privacy Policy are available on the school website.
